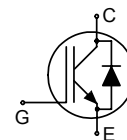

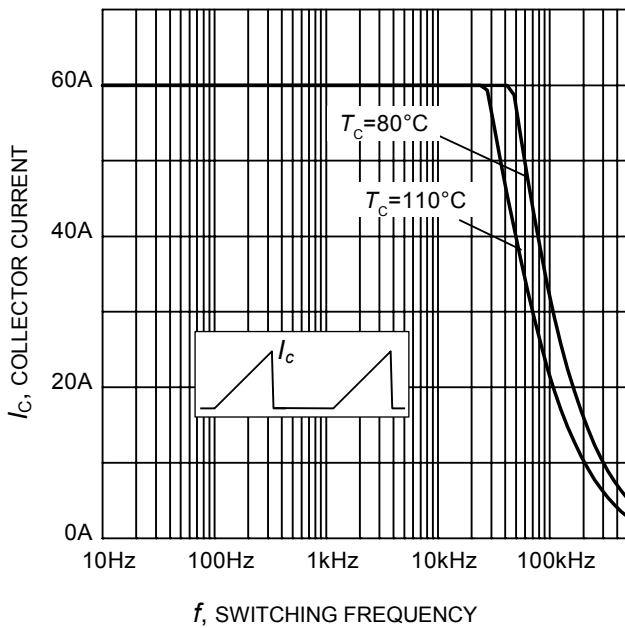


Figure 1. Collector current as a function of switching frequency for hard switching (turn-off)

 $V_{GE} = 0/+14\text{V}$, $R_G = 47\Omega$)

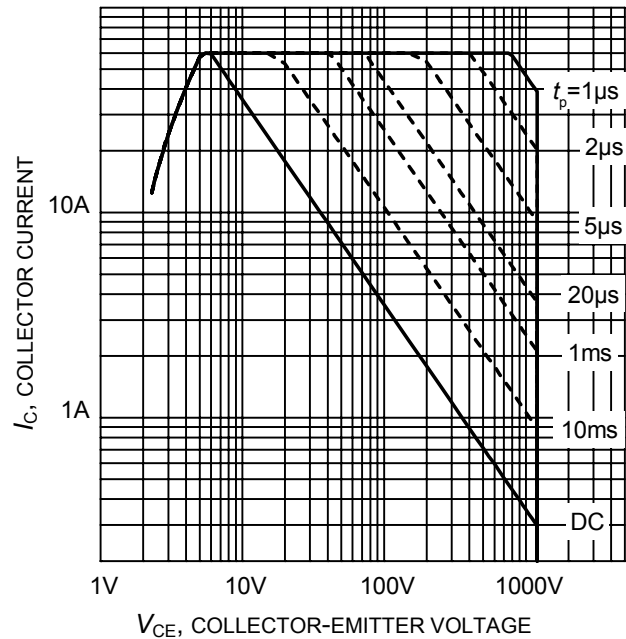


Figure 2. IGBT Safe operating area

 $T_j \leq 175^\circ\text{C}$; $V_{GE} = 14\text{V}$)

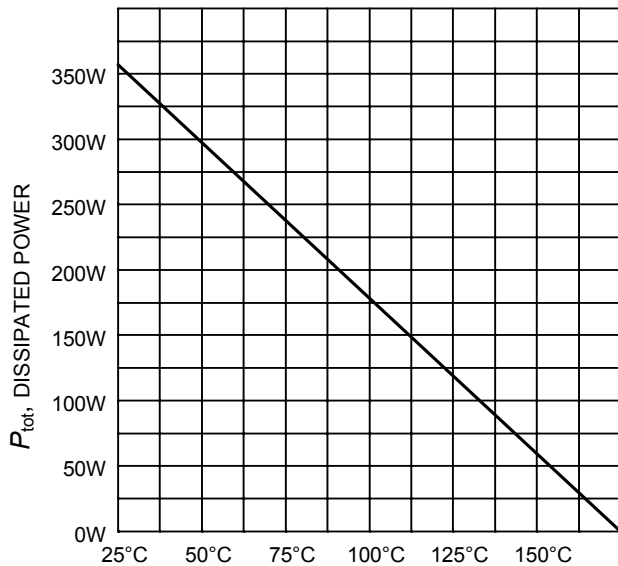


Figure 3. Power dissipation as a function of case temperature
 ($T_j \leq 175^\circ\text{C}$)

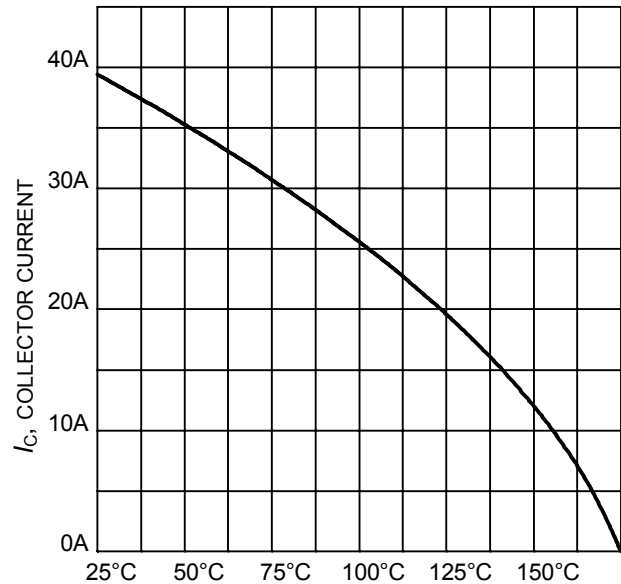


Figure 4. DC Collector current as a function of case temperature
 ($V_{GE} \geq 14\text{V}$, $T_j \leq 175^\circ\text{C}$)

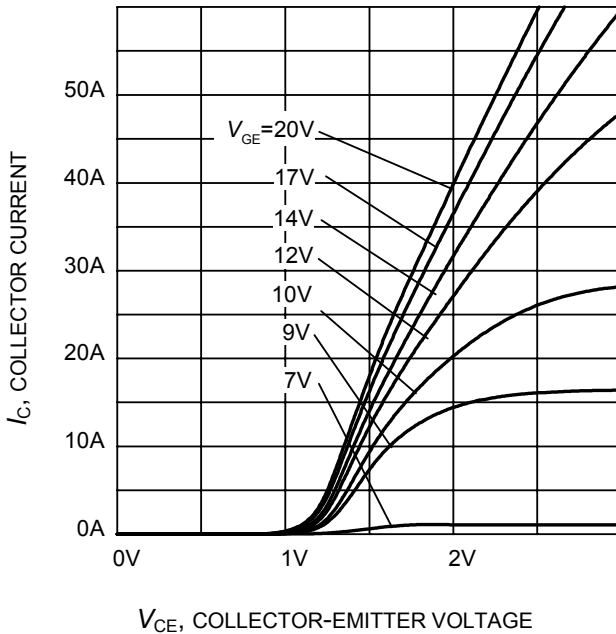


Figure 5. Typical output characteristic
($T_j = 25^\circ\text{C}$)

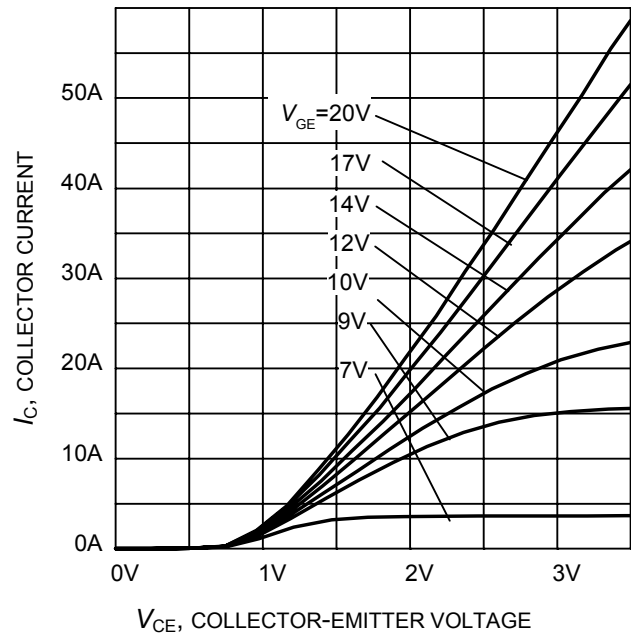


Figure 6. Typical output characteristic
($T_j = 175^\circ\text{C}$)

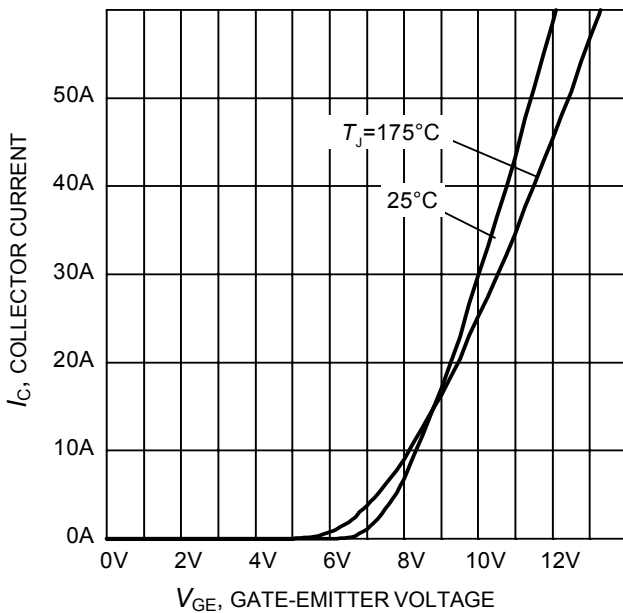


Figure 7. Typical transfer characteristic
($V_{CE} = 20\text{V}$)

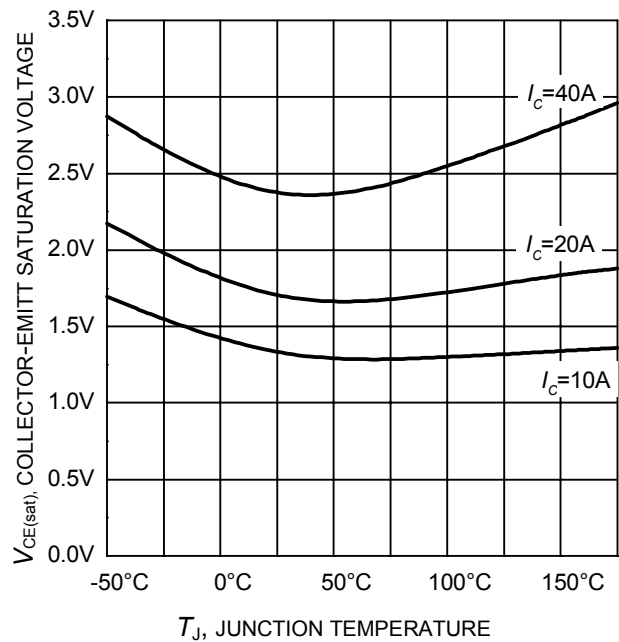


Figure 8. Typical collector-emitter saturation voltage as a function of junction temperature
($V_{GE} = 15\text{V}$)

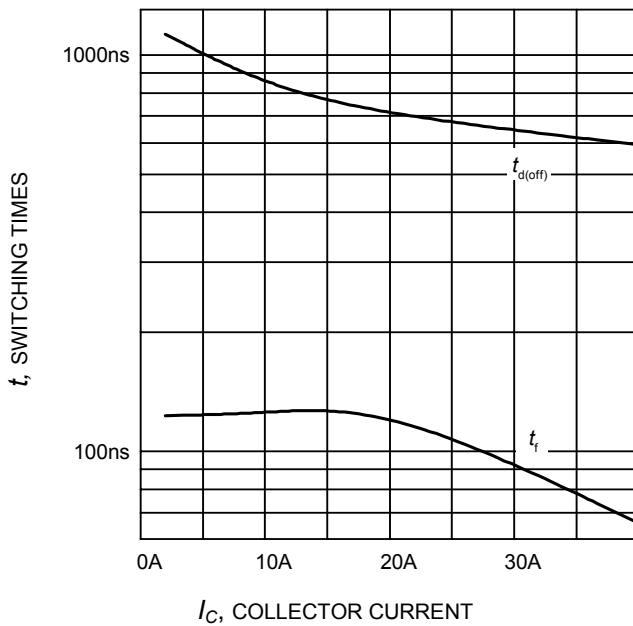


Figure 9. Typical switching times as a function of collector current

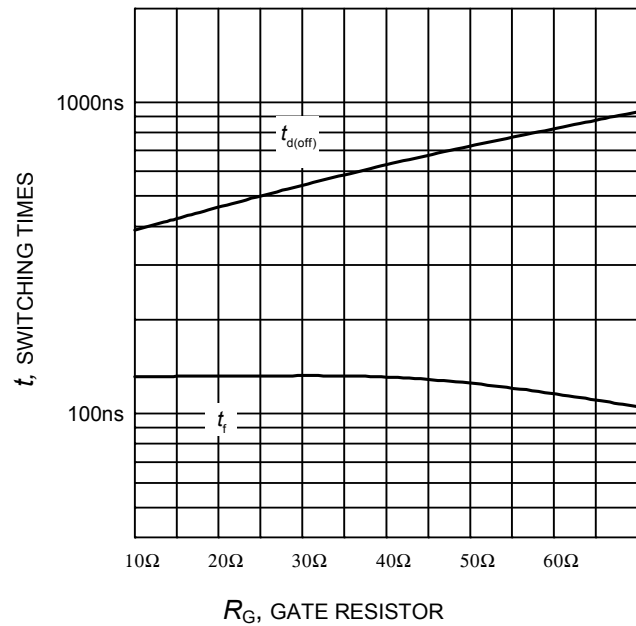


Figure 10. Typical switching times as a function of gate resistor

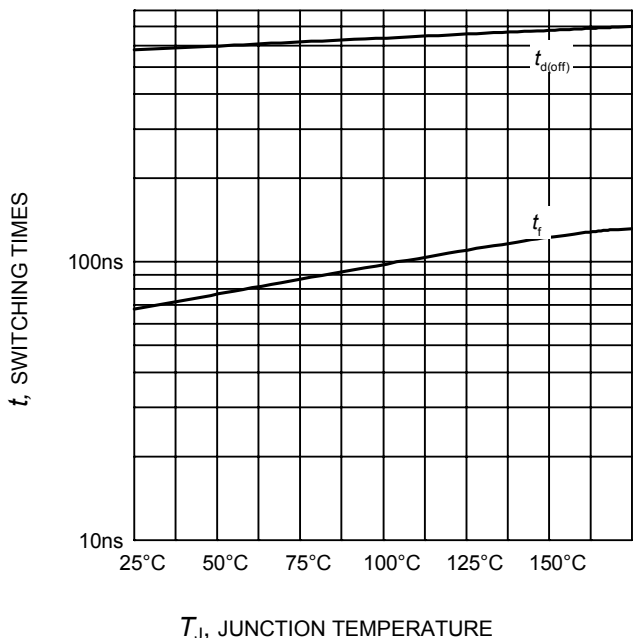


Figure 11. Typical switching times as a function of junction temperature

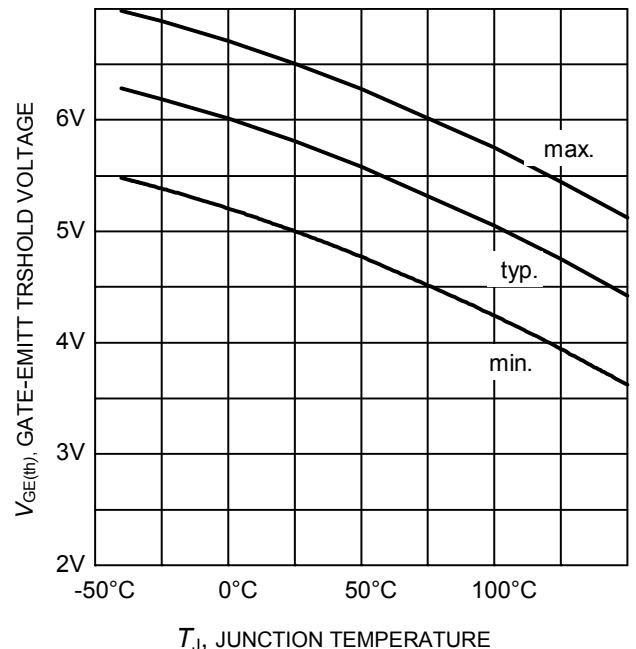


Figure 12. Gate-emitter threshold voltage as a function of junction temperature
 ($I_C = 0.7\text{mA}$)

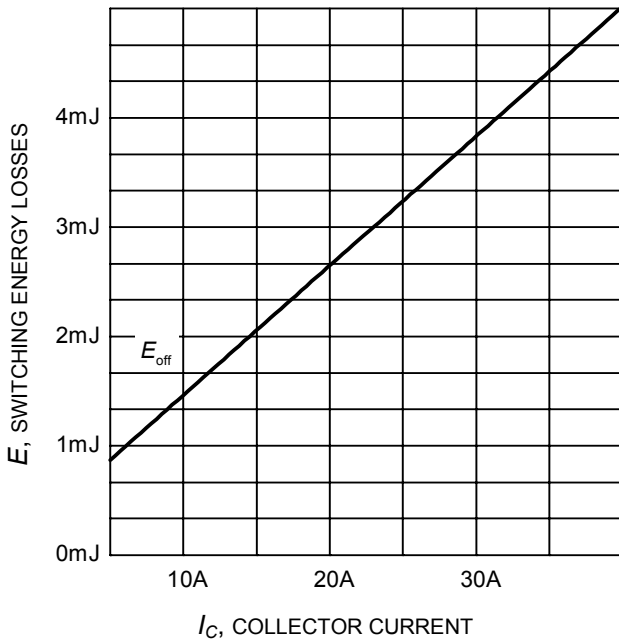


Figure 13. Typical turn-off energy as a function of collector current

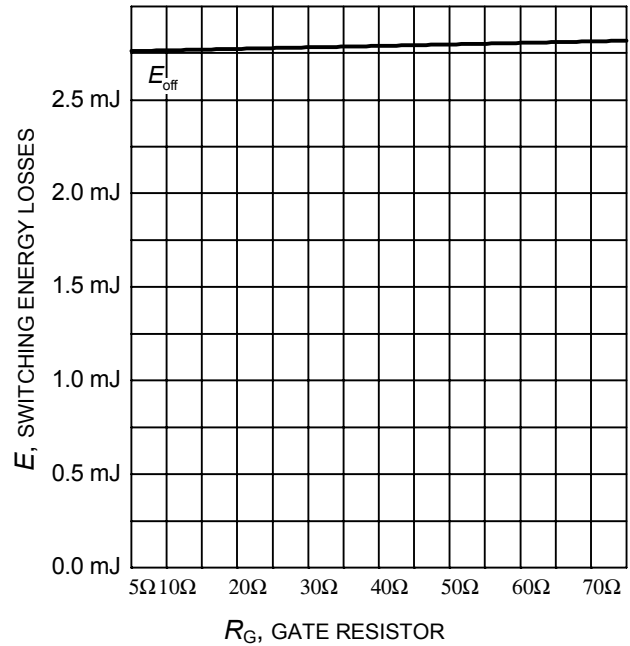


Figure 14. Typical turn-off energy as a function of gate resistor

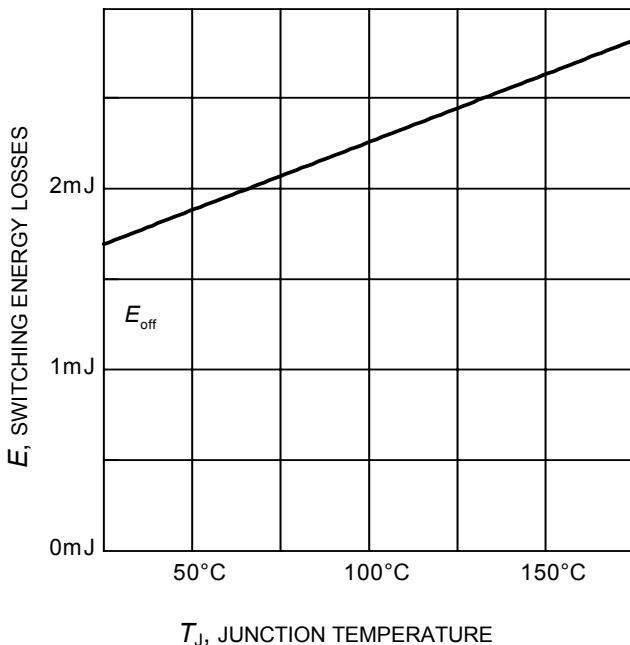


Figure 15. Typical turn-off energy as a function of junction temperature

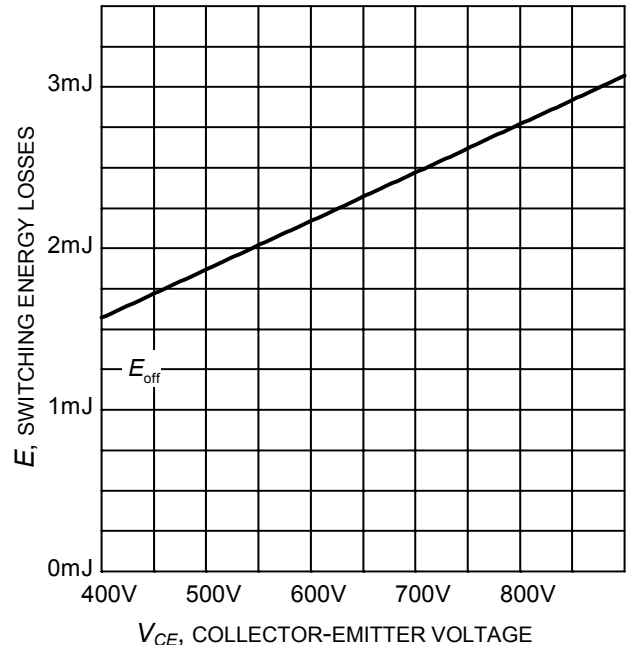


Figure 16. Typical turn-off energy as a function of collector emitter voltage

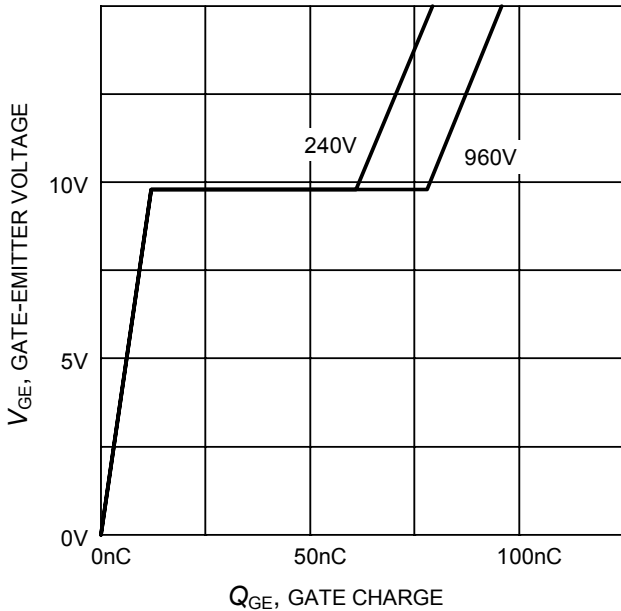


Figure 17. Typical gate charge
($I_C=20\text{ A}$)

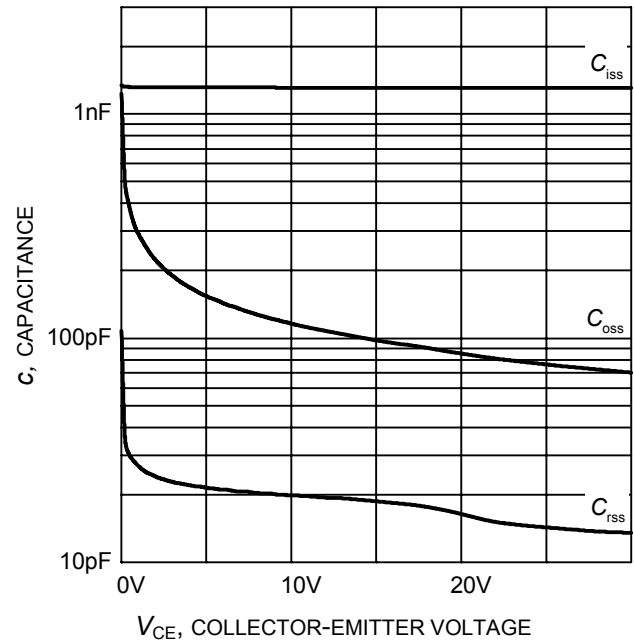


Figure 18. Typical capacitance as a function of collector-emitter voltage
($V_{GE}=0\text{V}$, $f=1\text{ MHz}$)

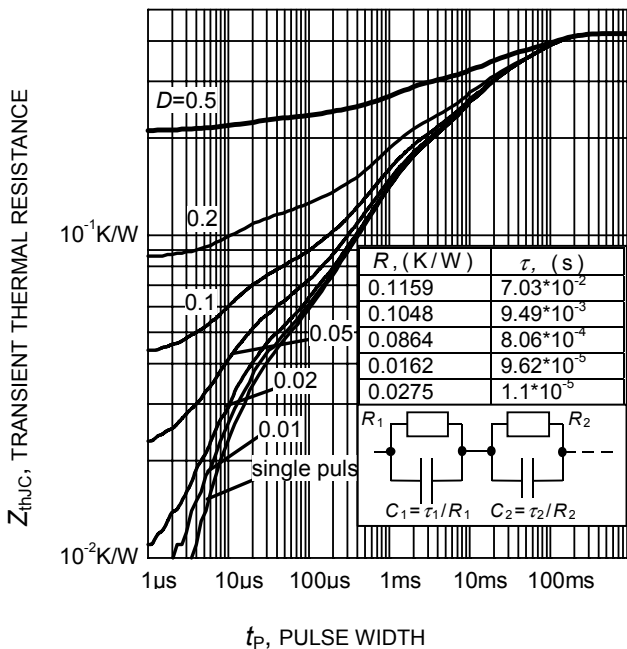


Figure 19. IGBT transient thermal resistance
($D = t_p / T$)

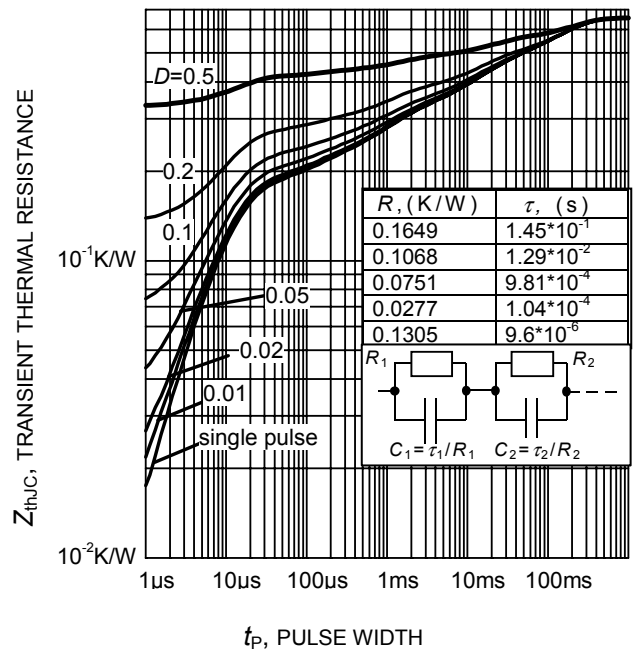


Figure 20. Typical Diode transient thermal impedance as a function of pulse width
($D=t_p/T$)

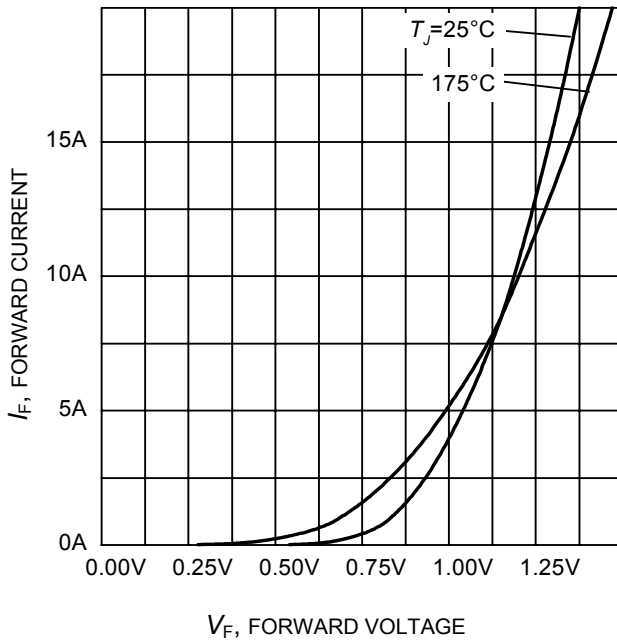


Figure 21. Typical diode forward current as a function of forward voltage

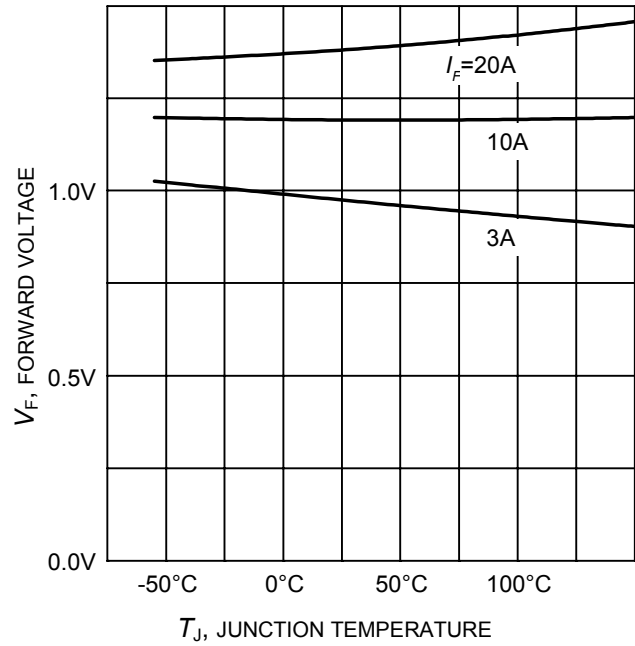
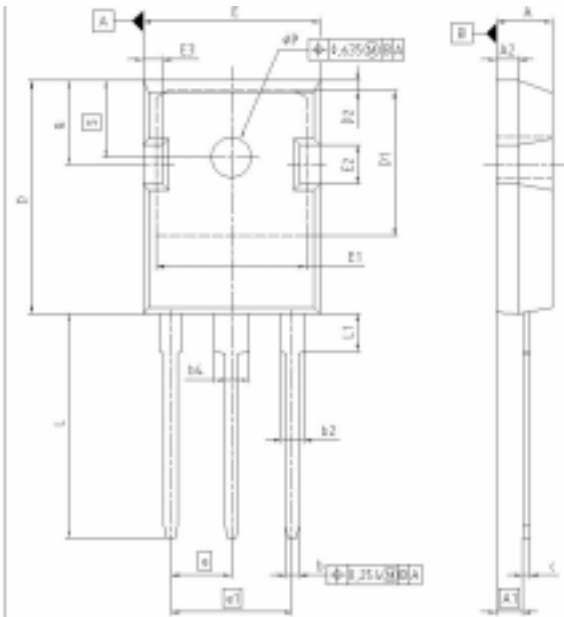


Figure 22. Typical diode forward voltage as a function of junction temperature

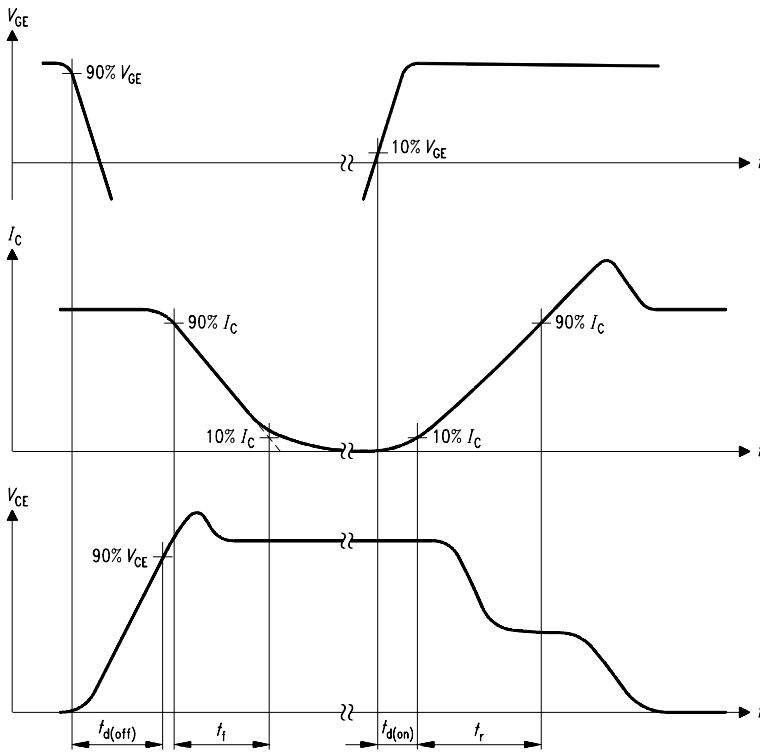


Figure A. Definition of switching times

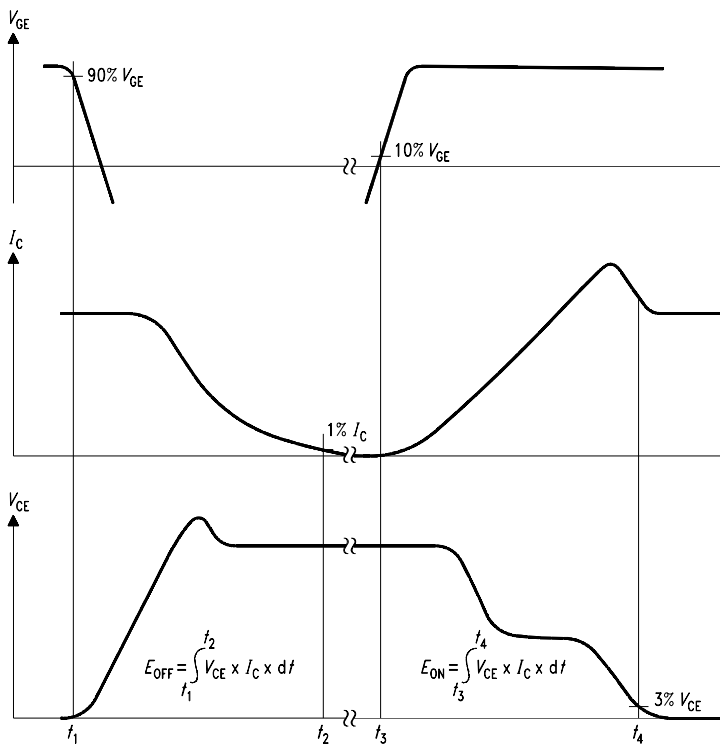


Figure B. Definition of switching losses

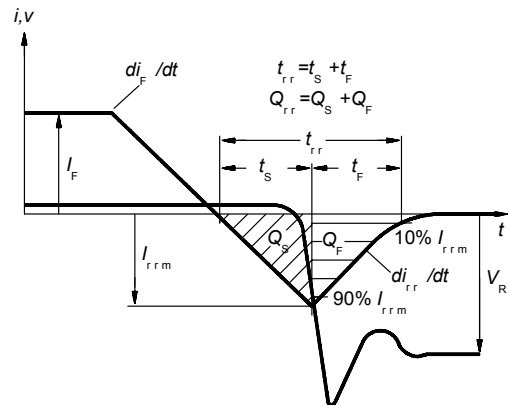


Figure C. Definition of diodes switching characteristics

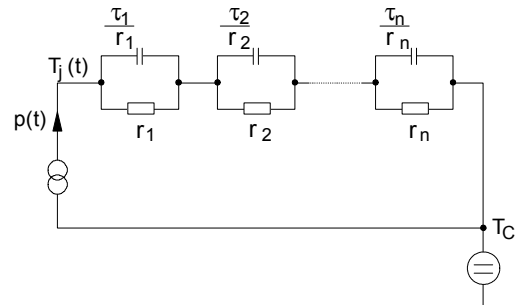


Figure D. Thermal equivalent circuit

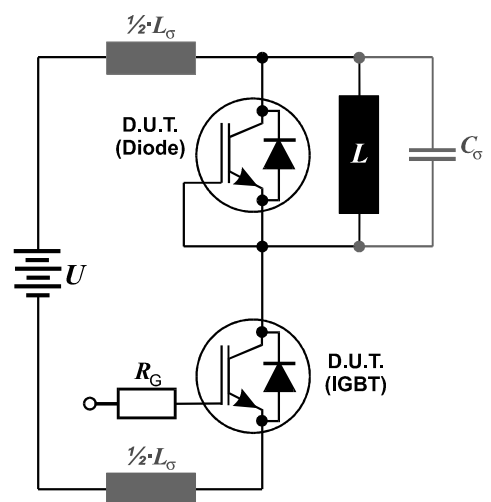


Figure E. Dynamic test circuit
